The SFPA has worked hard to establish a unique image and identity for this logo. Our objective is to continue to draw on this image and develop brand loyalty towards the Saskatchewan Made logo and the “Buy Local” concept. We are proud that you, the membership of our Association has chosen to use this logo to identify your products.

As part of our continuing efforts to ensure our SaskMade logo is used with integrity, we, the Saskatchewan Food Processors Association require that all members agree to abide by the following policies and procedures if you have the intention of using the logo on your product(s):

Regular Members:

- 1) Be a Regular member in good standing of the Saskatchewan Food Processors Association
A member in good standing is defined as: Current on membership and other dues.
- 2) Ensure the usage of all SaskMade logos are approved by a member of the SFPA management team. This includes using the logo on labels, point of sale material, at trade shows or for any other member promotional products.
- 3) In the event a member terminates his or her membership for any reason, he or she must cease usage of all products with the SaskMade logo.

Associate Members:

- 1) Associate members may only use the logo if the majority of their product is SaskMade.
- 2) All logo approvals are on an individual basis.
- 3) The remainder of policy and procedures follow the same criteria as the Regular membership.
